The under mentioned scrap items are to be disposed "AS IS WHERE IS BASIS" with details of terms and conditions as under:-

Iron, Wooden, Electrical, Aluminium, steel, plastic, solar panels with iron frames & other Misc. items – lying in the College Hostel premises.

Terms and Conditions:-

1. Sealed quotations should be submitted in the name of The Warden, Lady Shri Ram College for Women (University of Delhi) Hostel, Lajpat Nagar, New Delhi-110024, super scribed as 'Quotation for Scraps'. The Bidder must be registered with GST and Income Tax Authority.
2. The Bidder should clearly mention a valid GST No./PAN No.
3. Bidder must submit a Demand Draft for Rs.1,000/- (Rupees One Thousand Only) as Security Deposit amount in the name of Principal, Lady Shri Ram College for Women, which will be refunded on the same day i.e. after finalization of the process's except the highest bidder & 2nd bidder.
4. Last date for submission of bid is 29th January 2026 till 12.00 noon.
5. The Bid must be submitted in the Hostel office of the College till 12 noon on or before 29th January 2026 in a sealed envelope.
6. The quotations will be opened on the same date/day at 1.30P.M.
7. The bid will be offered to the highest bidder.
8. Incomplete Bid in any manner or submitted after due date would be summarily rejected.
9. The Hostel will not be responsible for any postal delay or delay for any reason.
10. The bidder should physically inspect the scrap from 24th January, 2026 to 28th January 2026, between 10:00 A.M. to 2:00 P.M. on any working day in the Hostel. After that day no inspection will be allowed.
11. The full and final amount of the bid must be deposited by the successful bidder before lifting of the scrap and the site must be cleared within a day.
12. The amount has to be deposited in the shape of an Online/NEFT/Bank through as full and final payment.
13. Bidder is responsible for labour charges such as for packing and loading, if any.
14. In case the highest bidder will not lift the scraps within stipulated period the earnest money will be forfeited and the next higher bidder will be invited and so on.
15. Hostel reserves the right to reject any quotation and may even cancel the process at any stage without assigning any reason thereof.
16. The Hostel reserves the right to (i) Discontinue/terminate the process at any stage without being liable to any one and assigning any reason; (ii) And Exclude the party from any consideration if the documents/information is not provided as required or incomplete or lacking or the college Hostel has sufficient ground that it can go against the college Hostel interests at any stage; and (iii) Take the appropriate steps action as warranted from time to time if not satisfied with the work or supplier and delivery of services as per rules in the interest of the college Hostel.
